ITEM 720-V

KRL CHARGES FOR USE, NON-USE/SET-BACK AND DETENTION ON HEAVY CAPACITY OR SPECIAL TYPE FLAT CAR APPLICATION

1. Charges assessed under this item will accrue to KRL and are assigned and payable to Kasgro Rail Lines, 320 East Cherry St., New Castle, PA 16102.
2. The use or detention charges will apply on KRL cars when these cars are furnished for use in line-haul or switching service for all carriers.
3. Charges assessed under this item will be in addition to any other charges, including normal demurrage charges..
4. These charges will apply at or between all stations in the United States, and/or Canada and/or Mexico.
5. If a KRL car is not listed in this item but is listed in the HEAVY DUTY AND SPECIAL FLAT CAR section of Tariff RER 6413 series, the use charge will be that provided for Rate Group H. Also, the additional detention and Non-use/Set-back Rate Group H charges will apply to the unlisted car.
6. When CSXT is origin carrier any and all applicable use and detention charges will be billed and collected by KRL. When CSXT is delivering carrier any and all destination detention will be billed and collected by KRL.
7. When UP is origin and/or destination carrier any and all applicable detention charges will be billed and collected by KRL. KRL will also be responsible for billing and collection of all use charges accrued on the UP.
8. When NS is origin carrier, any and all applicable use and detention charges will be billed and collected by KRL; also, when NS is the delivering carrier, any and all destination detention will be billed and collected by KRL.
9. When PAL is origin carrier, any and all applicable use and detention charges will be billed and collected by KRL; also, when PAL is the delivering carrier, any and all destination detention will be billed and collected by KRL.
10. When KCS or GWWR is origin carrier, any and all applicable use and detention charges accrued on the KCS or GWWR will be billed and collected by KRL; also, when KCS or GWWR is the delivering carrier, any and all destination detention accrued on the KCS or GWWR will be billed and collected by KRL.
11. When BNSF is origin carrier, any and all applicable use and detention charges accrued will be billed and collected by KRL; also, when BNSF is the delivering carrier, any and all destination detention accrued on the BNSF will be billed and collected by KRL.
12. When ST is origin carrier, any and all applicable use and detention charges accrued will be billed and collected by KRL; also, when ST is the delivering carrier, any and all destination detention accrued on the ST will be billed and collected by KRL.
13. When FEC is origin carrier, any and all applicable use and detention charges will be billed and collected by KRL. When FEC is the delivering carrier, any and all destination detention charges will be billed and collected by KRL.
14. When CPRS is origin carrier, any and all applicable use and detention charges will be billed and collected by KRL. When CPRS is the delivering carrier, any and all destination detention charges will be billed and collected by KRL.
15. When CN is origin carrier, any and all applicable use and detention charges will be billed and collected by KRL. When CN is the delivering carrier, any and all destination detention charges will be billed and collected by KRL.

ITEM 720-V CONT'D

DETENTION CHARGES

- A. When KRL cars are held, detention charges (in dollars per car) will be assessed for each 24-hour period, or fraction thereof, after the first 0001-hour after placement, or after notification if car is held enroute.
- B. Placement is defined as follows:
1. ACTUAL - When a car is placed in an accessible position for loading or unloading, or at a point designated by the consignor or consignee.
 2. CONSTRUCTIVE - When a car cannot be actually placed because of any condition attributable to the consignor or consignee and the car is held on railroad tracks.

NON-USE/SET-BACK CHARGE

- A. When a KRL car has been ordered and shipper is notified by carrier of car number assigned, and car is enroute and then the car is canceled the Non-use/Set-back charge will be charged to the shipper or party ordering the car. Should the shipper or party ordering the car set back the loading date up to 15 days the lesser of: the actual detention or the Non-use/Set-back Charge will be assessed. Cars with set-back dates in excess of 15 days will be billed the tariff detention rate from the new loading date until the car is released loaded or an additional "Use Charge", whichever is lesser. Also an additional "Use Charge" for each 30 day period thereafter will be charged as a monthly storage rate. Kasgro retains the right to move any car that has been set-back for 30 days or more, however, this will not eliminate charges accrued.
